**AN ORDER CREATING THE EXECUTIVE COMMITTEE OF THE
52nd ARAW NG DAVAO ORIENTAL CELEBRATION OF
THE PROVINCE OF DAVAO ORIENTAL**

WHEREAS, on July 1, 1967 by virtue of Republic Act 4867, the Province of Davao Oriental was created as one of the provinces in the Philippines. Through the years its foundation anniversary was proudly and gaily celebrated by its people spearheaded by the provincial government of Davao Oriental;

WHEREAS, Section 16 of the Local Government Code states "...within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice...";

WHEREAS, in 2019, the Champion Province, after its successful previous Anniversary celebration will celebrate its new era;

WHEREAS, anchored on this, the celebration endeavors to sustain, develop, inform and entertain its constituents with bustling events which focus on conservation of heritages and promotion and marketing of its tourism industry;

WHEREAS, this year's celebration intends not only to commemorate the foundation of the Province but importantly aims the following:

1. Bring to the conscious mind of Oriental Dabawenyos the importance of conserving the Davao Oriental heritages as an important factor of life;
2. Local crafts, arts and products are exposed and showcased;
3. The Provincial Government's Programs and Achievements are featured, exhibit, related and reported to its constituents;
4. In the culture and arts, local talents are assessed, developed and showcased; and
5. Davao Oriental constituents and tourists are educated and entertained.

NOW THEREFORE, I, NELSON L. DAYANGHIRANG, Provincial Governor of Davao Oriental, by virtue of the power vested in me by existing laws, do hereby order the creation of the Executive Committee for the 52nd Araw ng Davao Oriental celebration to be composed of the following, likewise to perform functions and activities consonant with pertinent policies and directives as well as enactments for the development, conservation and sustainability of the cultural and natural heritages, economy, health, disaster mitigation, peace and order, governance and tourism industry of the province to wit:

Section 1. COMPOSTION

The 51st ARAW NG DAVAO ORIENTAL EXECUTIVE COMMITTEE shall be composed of the following:

Section 2. MANDATE

The Executive Committee shall be the primary planning, coordinating and implementing entity of the 52nd Araw ng Davao Oriental foundation anniversary celebration and will work in the achievement of the objectives and goals especially in the development and promotion of tourism industry in coordination with the local government units and other government instrumentalities and private stakeholders.

Section 3. POWERS AND FUNCTIONS OF THE COMMITTEE

The Executive Committee shall have the following powers and functions, to wit:

- a. Work for strong partnership and collaboration among all stakeholders of the different sectors in attaining the objectives of celebration;
- b. Conceptualize plans and activities that will enliven the celebration.
- c. Implement and carry out, to the best of their abilities, events and activities of the celebration that will foster socio-economic development, cultural growth, ecological preservation and public safety;
- d. Act as an accreditation and approving body in matters pertaining to sponsorships, private events accreditation, merchandising and marketing.
- e. Perform such other related functions and duties as it may deemed necessary.
- f. Raise funds

Section 4. MEETINGS

The Executive Committee shall meet regularly for the discussion of the objectives, activities and events of the celebration upon notice of the Chairperson without prejudice of calling a special meeting if necessary.

However, committee meetings may be undertaken, every now and then, by the different committees and organizing teams respectively.

Section 5. FUNDING

Funds necessary to implement the provisions of this Order shall be appropriated upon the recommendation of each of the committee chairpersons duly approved by the Chairperson. Funds shall be raised by the Ways and Means and Finance Committees.

Section 6. SEPARABILITY CLAUSE

If for any reasons, any part of this Order shall be held unconstitutional or invalid, other parts or provisions thereof not affected thereby shall continue to be in full force and effect.

Section 7. EFFECTIVITY

This executive order shall take effect immediately.
