**"AN EXECUTIVE ORDER CREATING THE COMPOSITION ON GAD AND WOMEN'S
PROGRAM IMPLEMENTATION IN THE PROVINCE AND
DEFINING ITS DUTIES AND FUNCTIONS"**

WHEREAS, the Joint Memorandum Circular No. 2013-01 emphasizes guidelines on the localization of the Magna Carta of Women or RA 9710 in prescribing the policies and procedures in mainstreaming gender perspectives in local planning, programming and budgeting; local legislation; project development, implementation, monitoring and evaluation;

WHEREAS, recognizing the equality of women and men, the Provincial Government in Davao Oriental will pursue women's empowerment and gender-equality pursuant to RA 7160 or the Local Government Code of 1991 (LGC), the General Appropriations Act (GAA), the MCW and other international commitments;

WHEREAS, the Provincial Government in Davao Oriental ensures its commitment to implement programs which cross-cuts to gender responsiveness and sensitiveness;

NOW, THEREFORE, I, **NELSON L. DAYANGHIRANG**, Provincial Governor, by the powers vested in me by the Constitution and existing laws of the Republic of the Philippines, do hereby creating the composition on GAD and Women's program implementation in the province.

SECTION 1. Composition:

Head:	MS. SARAH G. GUDES, RSW -	PGDH-PSWDO
GAD Focal Person:	MR. RESTIE N. AGUILON -	CAO II/PGO
WOMEN'S Focal Person:	MS. EVELYN S. VALLAR -	Technical Consultant

SECTION 2. Duties and Functions:

1. The Head

- a.) To take part in Provincial Gender and Development Focal Point System (GFPS) as among the Executive Committee (ExeCom) members,
- b.) To oversee programs, projects and activities to be implemented under GAD and Women's activities;
- c.) To ensure program sustainability and critical consciousness to gender and development.

2. The Provincial GAD Focal Person

- a.) To take part in Provincial Gender and Development Focal Point System (GFPS) as Technical Working Group (TWG) Chairperson;
- b.) To lead in mainstreaming Provincial GAD perspective policies;
- c.) To coordinate efforts of different divisions/offices/units in the province and advocate for the integration of GAD perspectives in all systems and processes;

d.) To spearhead the preparation of the annual and performance-based GAD Plan and Budget (GPB), the consolidation of regular submission of accomplishment reports, and updating the sex-disaggregated data or GAD database to serve as basis in performance-based and gender-responsive planning and budgeting.

3. The Women's Focal Person

- a.) To lead the implementations of women's program in the province;
- b.) To coordinate local women's council/organization in updating women's welfare and situations in the province;
- c.) To formulate women's incoming programs such as submission of Annual GPB and accomplishment reports to GFPS.

SECTION 3. Repealing Clause:

All other earlier orders and previous issuances contrary or inconsistent herewith are hereby repealed, revoked, rescinded or superseded.

SECTION 4. Effectivity:

This Executive Order shall take effect immediately and shall remain in force until further orders.
