"AN EXECUTIVE ORDER CREATING AN INSTITUTIONAL STRENGTHENING
COMMITTEE"

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code (LGC) of 1991 stipulated at Chapter 3, Article 1, Section 465-B, that the Local Chief Executive (LCE) shall provide efficient, effective and economical governance for the general welfare of the province and its inhabitants;

WHEREAS, the Provincial Government recognizes the need to improve its organizational capacity to be responsive to the development thrust and direction of Davao Oriental;

WHEREAS, the Provincial Government shall pursue as its top priority the industrialization of agriculture and tourism sectors;

NOW, THEREFORE, I, NELSON L. DAYANGHIRANG, Governor of Davao Oriental, by virtue of the powers vested in me by law, do hereby order the creation of the Institutional Strengthening Committee.

SECTION 4 – Meetings

The Committee shall conduct its regular every 2nd Monday of the Month or shall convene anytime as need arises.

SECTION 5 – Honoraria

On basis of the foregoing, the Institutional Strengthening Committee members and its Secretariat shall be entitled to receive honoraria, subject to the usual accounting and auditing rules and regulations, as follows:

- Technical Advisors - P8,000.00/month
- Members - P5,000.00/month
- Secretariat - P4,000/month

SECTION 6 – Repealing Clause

All Executive Orders, rules and regulations or parts thereof, which are inconsistent with any provision of this Executive Order are hereby repealed, amended or modified accordingly.

SECTION 7 – Effectivity

This executive order shall take effect immediately.
