EXECUTIVE ORDER NO. 11

REQUIRING ALL LOCAL CHIEF EXECUTIVES (PUNONG BARANGAY/CITY/MUNICIPAL MAYORS) TO PROVIDE SUPPORT TO THE COMMUNICATION CONCERNS OF THEIR LGU IN SUPPORT TO THE MILITARY OPERATIONS OBTAINING WITHIN THEIR AREA OF JURISDICTION

WHEREAS, there is a need for the LGU to provide support to the Philippine Army in time of their military operations;

WHEREAS, Communication is a big factor in the preservation of peace and order and public safety and whenever a military operations will be conducted in a certain area, hence, the LGU shall purchase communications equipments chargeable against their peace and order funds or from their disaster funds (70% allocation);

NOW, THEREFORE, I, Nelson L. Dayanghirang, Governor, Province of Davao Oriental by virtue of the powers vested in me by law, do hereby order:

SECTION I. COORDINATION. The following instrumentalities are hereby directed to adhere to this communications flow, viz:

Barangay/City/Municipal/Provincial Levels:

- All Punong Barangays must coordinate with the following:
 - Punong Barangay to their respective Mayors;
 - Punong Barangay to their PNP-COP;
 - Punong Barangay to their Detachment Commander of the AFP
- All City/Municipal Mayors must coordinate with their PNP-COP and AFP- Battalion Commanders and vice versa;
- PNP-COP must coordinate with the Provincial PNP Office/DOPPO;
- Battalion Commanders must coordinate with the 701st Brigade Commander;
- The Provincial PNP and Brigade Commander must coordinate with other instrumentalities/offices concerns are on peace and order, fire prevention and safety, disaster preparedness such as the BFP -Provincial Fire Marshall, Provincial Disaster Risk and Management Officer (PDRMO), coast guard and other concerned agencies.

SECTION II. FUNCTIONS. The following are the mandated functions, to wit:

1. All local chief executives (barangay/city/municipal levels) shall appropriate fund from their local peace and order council or from the 70% of their Disaster Risk Reduction Management Fund to support the military operations in their area of jurisdiction;

2. They can purchase communication equipments to strengthen the coordination between the barangay to the city/municipal and provincial levels;
3. Perform such other functions as may be required by provincial authorities, policies or laws.

SECTION III. MEETINGS.

The peace and order concerns will be taken-up during the local peace and order council meeting/s (barangay/city/municipal/provincial levels) as often as necessary.


SECTION IV. FUNDING.

All LGUs (barangay/city/municipal and provincial levels) are directed to provide funding support to this endeavor particularly on the communications to include equipments that can help in the peace and security efforts of the LGU.

SECTION V. EFFECTIVITY.

This executive order shall take effect immediately.
