EXECUTIVE ORDER NO. 10

**CREATING THE TECHNICAL WORKING GROUP (TWG) UNDER PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) LEGAL LUMINARIES THAT WILL LOOK INTO THE LEGALITY OF THE OPERATION OF SALUGPONGAN, MISFI AND OTHER SIMILAR SCHOOLS IN THE PROVINCE OF DAVAO ORIENTAL**

**WHEREAS**, there are non-government schools in Davao Oriental operating in far flung barangays which cast doubts on the legitimacy of their operation;

**WHEREAS**, PPOC Resolution No. 06 Series of 2018 recommended to the Office of the Governor the creation of Technical Working Group (TWG) under Provincial Peace and Order Council (PPOC) legal luminaries that will look into the legality of the operation of *Salugpongan*, *Misfi* and other similar schools in the province of Davao Oriental;

**WHEREAS**, these schools mentioned above were non-compliant to the requirements of the K-12 Program of the DepEd;

**WHEREAS**, the continuous operation of these dubious schools, if remained unchecked, is detrimental to the welfare of the learners and may pose an emerging threat to the government.

**NOW, THEREFORE**, I, Nelson L. Dayanghirang, Governor, Province of Davao Oriental by virtue of the powers vested in me by law, do hereby order:

**SECTION I. COMPOSITION.** There is hereby created a Technical Working Group (TWG) under Provincial Peace and Order Council (PPOC) legal luminaries which shall be composed of the following:

**SECTION II. FUNCTIONS.** The Technical Working Group (TWG) shall have the following functions:

1. Take the lead in determining the legality of the operation of *Salugpongan*, *Misfi* and other similar schools operating in Davao Oriental;
2. Conduct an investigation, in coordination with other related agencies concerned, to establish the legitimacy of these schools and submit report and recommendation to the Provincial Peace and Order Council (PPOC);
3. Conduct continuous monitoring and evaluate the operation of schools similar to *Salugpongan* and *Misfi*, if any;
4. Perform such other functions as may be prescribed by competent authorities.

**SECTION III. MEETINGS.**

The Technical Working Group (TWG) shall conduct its regular meeting at least once every 6 months and/or as often as necessary.


**SECTION IV. FUNDING.**

Upon Recommendation of the Council, There shall be an allocation from Provincial Peace and Order Council (PPOC) Funds for Technical Working Group's (TWG) official activities.

**SECTION V. EFFECTIVITY.**

This executive order shall take effect immediately.
