EXECUTIVE ORDER NO. Series of 2019

AN ORDER EXPANDING THE COMPOSITION OF THE LOCAL FINANCE COMMITTEE (LFC) WITH TASK FORCE ON REVENUE GENERATION (TFRG), ITS SECRETARIAT AND FUNCTIONS

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provided for the creation of the Local Finance Committee in every local government unit:

WHEREAS, the Local Finance Committee (LFC) was created by virtue of Executive Order No. 1, series of 2016, expanded under Executive Order No. 7, series of 2018, and reconstituted under Executive Order No. 1, series of 2019;

WHEREAS, the need to expand the composition of the Committee becomes imperative to further assist and advise the Governor in addressing budgetary and other fiscal matters;

NOW THEREFORE, by the powers vested in me by law, I, NELSON L. DAYANGHIRANG, Provincial Governor, do hereby ORDER/DIRECT the expansion of the Local Finance Committee (LFC), with Task Force on Revenue Generation (TFRG) and its Secretariat, and define its composition, duties and functions.

Section 1: Composition of the Local Finance Committee

Section 2: Duties and Responsibilities of the LFC

The LFC shall exercise the following:

- a. Shall perform duties and responsibilities set forth under the R.A. 7160;
- b. Assist the Governor in all activities to generate revenue sources for the general welfare of the local populace;
- Formulate and recommend to the Governor for the approval of the revenue generating policies, implementing guidelines and strategies, and applicable methods to ably attain objectives.

Section 3: Task Force on Revenue Generation

There shall be constituted a Task Force on Revenue Generation (TFRG) to assist the LFC in the advocacy on strategic direction for more effective revenue generation, namely:
