



EXECUTIVE ORDER NO. 22
Series of 2019

**CREATING A SPECIAL ORGANIZING COMMITTEE FOR THE 2019 MINDANAO CHAMPIONSHIP
OF THE UNITED BASKETBALL LEAGUE 18 & UNDER (BOYS) DEVELOPMENTAL GAMES**

WHEREAS, it is the policy of the Provincial Government of Davao Oriental to foster and promote youth and sports development from the grassroots level to enable all the young people of the province not only to sharpen their athletic skills but also to form values inherent in sports and play such as self-discipline, hardwork, teamwork, camaraderie, respect for law and order, sportsmanship and fairplay, and thus, develop a sound mind in a sound body;

WHEREAS, in furtherance of this policy, the Province of Davao Oriental accepted the hosting of this year's staging of the United Basketball League 18 and Under (Boys) Development Games (UBL 18U D-Games) Mindanao Championship on October 21-25, 2019;

WHEREAS, now on its 5th season, the UBL 18U (Boys) D-Games annual competition is a grassroots development program that provides an avenue for aspiring basketball players to develop their skills and prepare them for bigger events in the future, and is organized/owned/operated/managed and officially sanctioned by the UBL-ACEF Basketball Sports, Inc. and UBL Mindanao Referees Commission (UBL MINDRECOM);

WHEREAS, the holding of the cagefest in the province aside from having a trade and tourism potential due to the expected participation of ten (10) to twelve (12) teams/delegations coming from cities and provinces throughout Mindanao, will also showcase the capability of Davao Oriental in hosting big sporting events;

WHEREAS, there is a need to create a special body that will ensure the successful staging of this event;

NOW, THEREFORE, I, NELSON L. DAYANGHIRANG, Governor of the Province of Davao Oriental, by virtue of the powers vested in me by law, do hereby ORDER:

Section 1. A Special Organizing Committee, hereinafter referred to as "SOCCO", is hereby created with the primary task of formulating and implementing plans and procedures, in coordination with the United Basketball League (UBL) in the staging of the 2019 Mindanao Championship for 18 & Under (Boys) Development Games, as well as, directing and supervising all activities related thereto. It shall be composed of the following:

The SOCCO may form other Working Groups (WG) as it may deem necessary to help accomplish its functions related to the games such as:

- Venue/Billing/Equipment WG
- Security WG
- Information/Communication/Documentation WG

- Medical Services WG
- Procurement/General Services Support WG
- Transportation WG
- Secretariat

Section 2. The SOCCO herein constituted shall have the following functions:

- Formulate and implement a work plan & budget for the proper hosting of the 2019 Mindanao Championship of the UBL 18U D-Games;
- Promote awareness, interest and enthusiasm regarding the said sporting event among the residents of the province, most especially the youth;
- Coordinate with various sectors and stakeholders in mobilizing support and resources for the cagefest;
- Consult and closely coordinate with the UBL thru its Executive Director, Mr. Ceferino A. Ayco;
- Formulate and implement plans and procedures on the security and safety of delegations/teams, guests, officials and others, visiting contingents and guests, health and sanitation and emergency response;
- Ensure the availability of equipment and worthiness of sport facilities and billeting centers/quarters;
- Perform other functions as it may deem necessary or incidental for the successful staging of the UBL 2019 Mindanao Championship.

Section 3. All provincial offices are hereby directed to extend needed support and make available resources, manpower, machines, materials, facilities, equipment, etc., for the successful conduct of this year's UBL Mindanao Championship games. All sectors of the community are likewise enjoined to cooperate and participate in the functions.

Section 4. The funds necessary for the hosting of the 2019 UBL Mindanao Championship games, including the operations of the SOCCO and Working Groups, shall be chargeable against the local funds.

Section 5. The Committee shall cease to exist thirty (30) days after the holding of the games and the submission of its Terminal Report, unless otherwise expressly directed by the Provincial Governor.

Section 6. If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

Section 7. Previous issuances or parts thereof in conflict with or inconsistent to the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 8. This Executive Order shall take effect immediately.
