

A RESOLUTION CONFIRMING THE APPROVAL ON THE ISSUANCE OF EXECUTIVE ORDER NO. 05, SERIES OF 2019, ISSUED BY THE CITY MAYOR, HONORABLE MICHELLE N. RABAT, WHICH READS AS: "REORGANIZING AND RECONSTITUTING THE CITY OF MATI TOURISM COUNCIL", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Executive Order No. 05, series of 2019, issued by Mayor Michelle N. Rabat, City Mayor of the City of Mati, dated July 19, 2019, "Reorganizing and Reconstituting the City of Mati Tourism Council" was received by the Sangguniang Panlalawigan Support Services Office on July 22, 2019, docketed as Communication No. 16-23-2019;

WHEREAS, Tourism is recognized by the City Government of Mati as one of the most important focused areas for development and is expected to generate economic activities in the City and therefore become a major contributor to the well-being of the community;

WHEREAS, there is a need to translate the community's creative and civic resource into a viable avenue where trends, policies and plans can be crafted into workable strategies that can eventually be institutionalized;

WHEREAS, the City of Mati Tourism Council is reorganized and reconstituted to reflect the changes in its membership;

WHEREAS, pursuant to Section 468 (a) (1) (i) of R.A. 7160, which states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Lemuel Ian M. Larcia, and Enrico M. Antopuesto, it was
