A RESOLUTION ALLOCATING THE AMOUNT OF THREE HUNDRED THOUSAND (P300,000.00) PESOS FOR FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY THE EARTHQUAKES OCCURRED IN THE MUNICIPALITY OF ITBAYAT, BATANES PROVINCE, LAST JULY 27, 2019.

WHEREAS, the Honorable Governor submitted an urgent request for the passage of an appropriate legislative action allocating the amount of THREE HUNDRED THOUSAND (P300,000.00) PESOS for financial assistance to the affected families due to the strong earthquakes that struck the town of Itbayat, Batanes Province, last July 27, 2019.;

WHEREAS, attached to the letter the approved Provincial Disaster Risk Reduction and Management Council Resolution No. 21, series of 2019, entitled: "A RESOLUTION

ALLOCATING THE AMOUNT OF THREE HUNDRED THOUSAND (P300,000.00) PESOS FROM THE CY 2019 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND OF THE PROVINCE OF DAVAO ORIENTAL, INTENDED AS FINANCIAL ASSISTANCE FOR THE FAMILIES AFFECTED BY THE EARTHQUAKES OCCURRED IN THE MUNICIPALITY OF ITBAYAT, BATANES PROVINCE LAST JULY 27, 2019 AND FORWARDING TO THE SANGGUNIANG PANLALAWIGAN FOR THEIR GUIDANCE AND APPROPRIATE ACTIONS.”;

WHEREAS, pursuant to Section 2 (p) of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, states that: “it is the policy of the State to provide maximum care, assistance and services to individuals and families affected by disaster, implement emergency rehabilitation projects to lessen the impact of disaster, and facilitate resumption of normal social and economic activities”;

WHEREFORE, on motion of SP Member Lemuel Ian M. Larcia, duly and jointly seconded by SP Members Dennis V. Roflo, Jr., Enrico M. Antopuesto, and Louis N. Rabat, it was

RESOLVED, as it is hereby resolved, **ALLOCATING THE AMOUNT OF THREE HUNDRED THOUSAND (P300,000.00) PESOS FOR FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY THE EARTHQUAKES OCCURRED IN THE MUNICIPALITY OF ITBAYAT, BATANES PROVINCE, LAST JULY 27, 2019;**
