

## PROVINCIAL ORDINANCE NO. 16-02-09-2019

AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2019 GENERAL FUND THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES FROM JULY 1 TO SEPTEMBER 30, 2019, MAINTENANCE AND OTHER OPERATING EXPENSES VARIOUS OFFICES, OTHER LOCALLY (MOOE) OF PROGRAMS/PROJECTS/ACTIVITIES AND APPROPRIATIONS FROM 20% LOCAL GOVERNMENT DEVELOPMENT FUND (LGDF), IN THE AMOUNT OF ₱27,611,610.16, AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS FUND VARIOUS PRIORITY TO PROGRAMS/PROJECTS/ACTIVITIES OF THIS PROVINCE.

WHEREAS, there are programs/projects/activities of the Provincial Government which aim on strengthening institutional capacity in health services delivery, implementing of activities that increase personnel performance and productivity, and other infrastructure projects that requires funding.

WHEREAS, the Local Finance Committee (LFC) has certified as to availability of funds needed for the implementation of the identified priority programs/projects/activities, and will be taken from the reversion of savings from salaries and other compensations of various offices, Maintenance and Other Operating Expenses (MOOE) of various offices, Other Locally Funded programs/projects/activities, and appropriations from 20% Local Government Development Fund (LGDF).

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. REVERSION - It is hereby approved the reversions to the CY 2019 Unappropriated Balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the appropriations for the savings from salaries and other compensations of various offices, Maintenance and Other Operating Expenses (MOOE) of various offices, Other Locally Funded programs/projects/activities, and appropriations from 20% Local Government Development Fund (LGDF) in the amount of **P27,611,610.16**, to wit:
