**A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO DONATE 660 SQUARE METERS OF LAND FOR THE ESTABLISHMENT OF PHILIPPINE NATIONAL POLICE (PNP) SUBSTATION AT THE PROVINCIAL GOVERNMENT CENTER, BARANGAY DAHICAN, CITY OF MATI, THIS PROVINCE.**

**WHEREAS**, the Honorable Governor Nelson L. Dayanghirang submitted a letter dated August 1, 2019, requesting this august body for the passage of a resolution authorizing him, for and in behalf of the Provincial Government of Davao Oriental, to donate 660 square meters of land for the establishment of Philippine National Police (PNP) Substation at the Provincial Government Center, Barangay Dahican, City of Mati;
