PROVINCIAL ORDINANCE NO. 16-08-10-2019

ORDINANCE CREATING THE LOCAL LEGISLATIVE-EXECUTIVE DEVELOPMENT ADVISORY COUNCIL (LLEDAC) IN THE PROVINCE OF DAVAO ORIENTAL.

WHEREAS, the preamble of the 1987 Constitution ordains and promulgates that "The Sovereign Filipino people imploring the aid of Almighty God, in order to build a just and humane society and establish a Government shall embody our ideals and aspirations, promote the common good, conserve and develop our patrimony, and secure to ourselves and our posterity, the blessings of independence and democracy under the rule of law and a regime of truth, justice, freedom, love, equality and peace;

WHEREAS, pursuant to RA 7640, otherwise known as "An Act constituting the Local Legislative-Executive Development Advisory Council (LLEDAC)", provides that it is the policy of the state to formulate after consultation with appropriate public agencies the private sector and the public government units, socio-economic development program taking into account the requirements of conservation and ecology and in accordance with its constitutional mandate to promote on more equitable distribution of

opportunities, income and wealth; a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and expanding productivity as the key to raising the quality of life for all, especially the underprivileged";

WHEREAS, in order to have a unified and harmonized measures for public welfare, the Local Legislative-Executive Development Advisory Council is hereby created to support the implementation of socio-economic developments in the Province to alleviate poverty;

WHEREAS, the LLEDAC provides direction to the provincial government in addressing the interests, concerns and aspirations of the majority poor both urban and rural;

NOW THEREFORE, be it ordained by the Sangguniang Panlalawigan of Davao Oriental on its session duly assembled, that;

SECTION 1. Title. This Provincial Ordinance shall be known as "An Ordinance Creating the Local Legislative-Executive Development Advisory Council in the Province of Davao Oriental and Appropriating Funds Thereof.

SECTION 2. Statement of Policy. It shall be the policy of the Provincial Government of Davao Oriental to:

- a. Promote a just and dynamic social order through policies that provide fair and honest competition in the pursuit of socio-economic progress;
- Sustain and advance the participation of the public regardless of status in life to avail of benefits intended for people's welfare;
- c. Establish a mechanism that will accelerate social progress and promote total human liberation and development.

SECTION 3. Definition of Terms. For purposes of this ordinance, the following terms are defined:

- a. Executive refers to a body having the power to execute, implement laws, rules and regulations and to manage, control programs, projects and activities.
- b. Legislative refers to a body having the power to make laws.
- c. Policy is a rule for action, manifesting or classifying specific organization goals, objectives, values or ideas and often prescribing the obligatory or most desirable ways and means for their accomplishment.
- d. Offices are grouped primarily on the basis of major functions to achieve simplicity, economy and efficiency on government operations and minimize duplication and overlapping of activities.
- e. Ordinance a law or decree established by authority for local application.
- f. Council an assembly convened for consultation, deliberation and advice.
- g. Advisory having the power to advice

SECTION 4. Creation and Composition of Local Legislative-Executive Development Advisory Council (LLEDAC) – The Provincial LLEDAC shall be created and composed of the following:

SECTION 5. Duties and Functions of the Local Legislative-Executive Development Advisory Council (LLEDAC). The LLEDAC shall have the following duties and functions:

a. To formulate the Executive-Legislative Agenda of the Province.

- b. To monitor, assess, evaluate the implementation of Executive-Legislative Agenda and other undertakings of the Provincial Government.
- c. To update policies and recommend legislative measures to the Sangguniang Panlalawigan for legislation.
- d. To serve as the advisory body of the Executive and Legislative branches of the Provincial Government.
- e. To enjoin all government institutions, civil society and private sectors to converge and create joint efforts in the pursuit of programs, projects and activities aimed at alleviating the quality of life of the constituents of the Province.
- f. To perform other duties and functions as maybe necessary or prescribed by law, ordinance and issuance.

SECTION 6. Creation of the Secretariat and its Composition.

- Secretariat shall be created to compose of the following:
 - Provincial Administrator
 - Provincial Planning and Development Coordinator
 - · Secretary to the Sangguniang Panlalawigan

SECTION 7. Secretariat Functions: The Secretariat shall be:

- a. Responsible in keeping records of the office/council;
- b. In charge of informing all members in the schedule of meetings, trainings and other similar activities;
- c. In charge of recording the minutes of the council and prepare communications addressed to clients and others concerned.

SECTION 8. MEETINGS. Meetings shall be held once every semester.

SECTION 9. Appropriation. The Provincial Government shall set aside reasonable allocation as initial funding to ensure functionality of Local Legislative-Executive Development Advisory Council (LLEDAC) in the performance of its duties and functions.

SECTION 10. Effectivity. This Ordinance shall take effect after posting in at least three (3) conspicuous places in the Province of Davao Oriental.
