DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A *MEMORANDUM OF AGREEMENT* WITH THE CITY GOVERNMENT OF MATI, REPRESENTED BY *HON. MICHELLE MARIE DENISE N. RABAT*, CITY MAYOR, IN RELATION TO THE IMPLEMENTATION OF HOSPITAL REFERRALS FOR OTHER LABORATORY EXAMINATION SERVICES NOT AVAILABLE IN THE CITY HEALTH OFFICE AND FOR MOTHERS AND NEWBORN CHILDREN NEEDING HIGHER LEVEL OF MATERNAL AND NEONATAL CARE OF THE CITY OF MATI BALAY PAANAKAN – NORTH, SOUTH, AND GIDA AND ACCREDITING DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC) AS ITS REFERRAL FACILITY.**

**WHEREAS**, the Referral Facility shall provide the following services (Laboratory and/or chest X-ray examination services): Chest X-ray – P180.00;

**WHEREAS**, the Referral Facility shall commence the provision of the Services on January 2, 2020 up to December 31, 2022;

**WHEREAS**, the payment for referred diagnostic services shall be charged against the Per Family Payment Rate (PFPR) Fund of the accredited PCB provider;




