ROSIT, MAYOR, IN RELATION TO THE RENEWAL OF ACCREDITATION TO PHILHEALTH'S PRIMARY CARE BENEFIT 1 PACKAGE ESTABLISHING THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC) AS REFERRAL HOSPITAL FACILITY FOR THE BOSTON RURAL HEALTH UNIT AS THE PCB 1 SERVICE PROVIDER.**

**WHEREAS**, the Referral Facility shall provide the following service ("Services") to the patients referred by the PCB Provider in accordance with the terms and conditions:

Fasting Blood Sugar	- P 100.00
Lipid Profile	- P 600.00
Chest X-ray PA view	- P 170.00
Chest X-ray APL view (Pedia)	- P 250.00
Chest X-ray ALV	- P 120.00



**WHEREAS**, the Referral Facility shall commence the provision of the Services on October 1, 2012 and shall continue until and unless terminated by Price;

**WHEREAS**, the payment for referred diagnostic services shall be charged against the Per Family Payment Rate (PFPR) Fund of the accredited PCB Provider.


