A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL GOVERNMENT OF BOSTON, REPRESENTED BY HON. ROWELL F. ROSIT, MAYOR, IN RELATION TO THE RENEWAL OF RURAL HEALTH UNIT OF BOSTON BIRTHING FACILITY (PAANAKAN) AS THE PRIMARY HEALTH FACILITY AND ESTABLISHING THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC) AS ITS AMBULANCE SERVICE PROVIDER.

WHEREAS, to ensure that quality care is provided to the patient, the PRIMARY HEALTH CARE FACILITY is required to have an AMBULANCE SERVICE PROVIDER for transporting patients needing higher level of medical care to the specialized referral hospitals;

WHEREAS, the AMBULANCE SERVICE PROVIDER shall be accredited by the Department of Health – Health Facilities and Services Regulatory Bureau (HFSRB) and has equipments and personnel trained in Basic Life Support (BLS) or Advanced Cardiac Life Support (ACLS);

WHEREFORE, on motion of SP Member Enrico M. Antopuesto, duly seconded by SP Member Ronald T. Lara, Jr., it was

RESOLVED, as it is hereby resolved, **AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL GOVERNMENT OF BOSTON, REPRESENTED BY HON. ROWELL F.
