AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2019 GENERAL FUND THE ACTUAL SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES; SAVINGS FROM MISCELLANEOUS PERSONNEL BENEFITS FUND (MPBF); SAVINGS FROM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF DIFFERENT OFFICES, OTHER LOCALLY FUNDED PPAS AND GENDER & DEVELOPMENT (GAD); SAVINGS FROM CAPITAL OUTLAY OF DIFFERENT OFFICES, OTHER LOCALLY FUNDED PPAs, GENDER & DEVELOPMENT (GAD), SENIOR CITIZEN & PWDs, AND LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC); AND APPROPRIATIONS FROM 20% LOCAL GOVERNMENT DEVELOPMENT FUND (LGDF), IN THE TOTAL AMOUNT OF ₱68,742,719.82, AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS/PROJECTS/ACTIVITIES OF THIS PROVINCE..

WHEREAS, there are programs/projects/activities of the Provincial Government aims at strengthening institutional capacity in social services delivery, implementation of activities that increase personnel performance and productivity, and other infrastructure projects that requires funding.

WHEREAS, the Local Finance Committee (LFC) have certified as to availability of funds needed for the implementation of the identified priority programs/projects/activities, and will be taken from the reversion of actual savings from salaries and other compensations of various offices; savings from MPBF; savings from MOOE of different offices, Other Locally Funded PPAs, and GAD; savings from Capital Outlay of different offices, Other Locally Funded PPAs, GAD, Senior Citizen & PWDs, and LCPC; and appropriations from 20% Local Government Development Fund (LGDF).

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. REVERSION - It is hereby approved the reversions to the CY 2019 Unappropriated balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the actual savings from salaries and other compensations of various offices; savings from MPBF; savings from MOOE of different offices, Other Locally Funded PPAs and GAD; savings from Capital Outlay of different offices, Other Locally Funded PPAs, GAD, Senior Citizen & PWDs, and LCPC; and appropriations from 20% Local Government Development Fund (LGDF) in the amount of **₱68,742,719.82**, to wit:


