A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCE OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTr), REPRESENTED BY ITS UNDERSECRETARY FOR AVIATION AND AIRPORTS, CAPT. MANUEL ANTONIO L. TAMAYO IN RELATION TO THE UTILIZATION OF TWO HUNDRED MILLION (\$\mathbb{P}200,000,000.00) PESOS INTENDED FOR SITE ACQUISITION OF THE MATI AIRPORT DEVELOPMENT PROJECT.

WHEREAS, Office of Congressman Joel Mayo Z. Almario, Representative of the 2<sup>nd</sup> District of Davao Oriental, raised the urgency of modernizing and developing the Mati Airport as an alternate airport to the Francisco Bangoy International Airport otherwise known as Davao International Airport;

WHEREAS, the Department of Transportation (DOTr) has allocated the amount of Two Hundred Million (P200,000,000.00) Pesos intended for site acquisition of the Mati Airport development project;

WHEREAS, the Provincial Local Government Unit of Davao Oriental has manifested its desire to support and assist the Department of Transportation (DOTr) in the implementation of the project by way of facilitating the acquisition of lots and the improvements found thereon, including documentation of the property transfer, and activities necessary or ancillary to site acquisition;
