A RESOLUTION CONFIRMING THE VALIDITY ON THE ISSUANCE OF EXECUTIVE ORDER NO. 69, SERIES OF 2019, ISSUED BY THE HONORABLE MAYOR MICHELLE N. RABAT, CITY OF MATI, DAVAO ORIENTAL, RE: "CREATING THE DESIGN AND BUILD COMMITTEE AND PROJECT IMPLEMENTATION UNIT FOR THE REHABILITATION OF BUSO HOT SPRING PARK".

WHEREAS, Executive Order No. 69, series of 2019, issued by Mayor Michelle N. Rabat, City of Mati, Davao Oriental was forwarded to the Sangguniang Panlalawigan for an appropriate action;

WHEREAS, the City Government of Mati is a recipient of P15,000,000.00 grant from the Local Government Support Fund — Other Financial Assistance to Local Government Units (LGSF-FA to LGUs) for the Rehabilitation of Buso Hot Spring Park;

WHEREAS, there is a need to create a Design and Build Committee to plan, design and implement the rehabilitation of Buso Hot Spring Park, in which its existing facilities are now dilapidated;

WHEREAS, Section 468 (a)(1)(i) of R.A. 7160 states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";
