WHEREAS, Municipal Ordinance No. 13-16-04-2019 was received by the Sangguniang Panlalawigan Support Services Office (SPSSO) last April 26, 2019 and was docketed as Communication No. 75-2019 and the same was referred to the Committee on Transportation & Communication, chaired by former Board Member Daud Linsag;

WHEREAS, Municipal Ordinance No. 13-16-04-2019 was enacted by the Sangguniang Bayan of Boston, Davao Oriental during its 108th regular session held on April 01, 2019 and the same was approved on April 01, 2019 by Municipal Mayor Rebecco B. Rosit, Sr.

WHEREAS, a Public Hearing was conducted on February 13, 2019 at the Municipality of Boston, Province of Davao Oriental;

WHEREAS, Section 468 (a)(1)(i) of R.A. 7160 states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREFORE, on motion of SP Member Enrico M. Antopuesto, duly seconded by SP Member Rabsalon M. Lamaran, it was
