A RESOLUTION CONFIRMING THE APPROVAL ON THE VALIDITY OF EXECUTIVE ORDER NO. 64, SERIES OF 2019, ENTITLED: "ADDENDUM TO EXECUTIVE ORDERS NO. 24 AND NO. 28, SERIES OF 2019, RE: CREATION OF THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) TEAM, BY THE ADDITION OF A TECHNICAL WORKING GROUP AND THE REMOVAL OF MS. CAMILA B. PUSTA AND ENGR. JOEL A. CAPALIT".

WHEREAS, Executive Order No. 64, series of 2019 issued by Mayor Michelle N. Rabat, City of Mati, Davao Oriental was forwarded to this Sangguniang Panlalawigan for appropriate action;

WHEREAS, the City/Municipal Government shall have the responsibility of formulating the Local public Transport Route Plan for intra-city/intra-municipal trips of public utility vehicles and the responsibility of collecting data, analyzing public transport supply and demand, and identifying specific public transport supply gaps for travel within their territories and for capturing this in city and municipal transport plans;

WHEREAS, Section 468 (a)(1)(i) of R.A. 7160 states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";
