**WHEREAS**, The Provincial Land Use Council (PLUC) executed the final review of the CLUP of the Municipality of Lupon, Davao Oriental, recommendations thereof were appropriately acted upon by the said Municipality;

**WHEREAS**, the enactment of the said Ordinance is within the legal powers of the Sangguniang Bayan;

**WHEREAS**, Section 468 (a)(1)(i) of R.A. 7160 states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";


**WHEREFORE**, on motion of SP Member Joselito B. Villademosa, duly seconded by SP Member Rabsalon M. Lamarin, it was


