A RESOLUTION CONFIRMING THE VALIDITY ON THE ISSUANCE OF EXECUTIVE ORDER NO. 41, SERIES OF 2019, ISSUED BY THE HONORABLE MAYOR MICHELLE N. RABAT, CITY OF MATI, DAVAO ORIENTAL, RE: "REORGANIZING AND RECONSTITUTING THE CITY DEVELOPMENT COUNCIL".

WHEREAS, Section 106 of the Local Government of 1991 otherwise known as Republic Act 7160 requires every local government unit to recognize the City Development Council as the body which shall initiative the formulation of a Comprehensive Multi-Sectoral Development Plan;

WHEREAS, there is a need to reorganize and reconstitute the City Development Council in the exigency of the service;

WHEREAS, Section 468 (a)(1)(i) of R.A. 7160 states that: "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of the component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";
