A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2019-09, ENTITLED: "AN ORDINANCE CREATING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) IN THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, PROVIDING ITS DUTIES AND FUNCTIONS AND APPROPRIATING FUNDS FOR ITS OPERATION THEREOF", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Republic Act No. 8759 otherwise known as the Public Employment Service Office Act (PESO) of 1999, conveys that the state shall provide full employment and equality of employment opportunities for all and for this purpose, to strengthen and expand the existing employment facilitation service machinery of the government particularly at the local levels;

WHEREAS, it is the policy of the Municipality of Lupon to adhere with the noble intent of RA8759 thereby creating an institution that primarily cater unemployment and underemployment gaps of the locality and further improve the process in hiring skilled workers and laborers for both domestic and foreign employment;

WHEREAS, the Public Employment Service Office (PESO) shall be a section under the office of the Municipal Mayor, who shall take charge of employment programs and services of the Municipality of Lupon, pursuant to the provisions of Republic Act 8759 of the PESO Act of 1999;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly seconded by SP Member Enrico M. Antopuesto, it was
