A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 385, SERIES OF 2019, ENTITLED: "AN ORDINANCE ABOLISHING ONE (1) ADMINISTRATIVE OFFICER III, SG-14 AND REVERTING ITS APPROPRIATION TO FUND THE CREATION OF THE REGULAR PLANTILLA POSITIONS ONE (1) LOCAL LEGISLATIVE STAFF EMPLOYEE II, SG-4 AND ONE (1) LOCAL LEGISLATIVE STAFF EMPLOYEE I, SG-2 UNDER THE SP SUPPORT SERVICES OFFICE, THIS CITY", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, City Ordinance No. 385, series of 2019 was transmitted and received by the Office of the Sangguniang Panlalawigan for review on December 10. 2019 and was referred to the Committee on Labor and Employment on January 15, 2020 for appropriate action;

WHEREAS, City Ordinance No. 385 series of 2019 was enacted by the Sangguniang Panlungsod of the City of Mati on December 3, 2019 during its 22<sup>nd</sup> Regular Session;

WHEREAS, the creation of the positions for the offices mentioned above are deemed necessary in order to augment the services of the said offices;

WHEREAS, Section 76 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that every local government units shall design and implement its own organizational structure and staffing pattern and taking into consideration its services requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly seconded by SP Member Ronald T. Lara, Jr., it was
