**A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG TO CAUSE/ORDER THE DEMOLITION OF THE OLD IPHO BUILDING AT DOPMC COMPOUND, CITY OF MATI, DAVAO ORIENTAL, TO PAVE WAY FOR THE CONSTRUCTION OF MEDICAL ARTS BUILDING.**

**WHEREAS**, the Honorable Governor submitted a letter dated February 26, 2020 requesting the august body for the passage of a resolution authorizing him to cause/order the demolition of the **old IPHO Building** at DOPMC Compound, City of Mati, Davao Oriental;

**WHEREAS**, per Inventory and Inspection Report of Unserviceable Property approved by the Honorable Governor, the said building is now dilapidated, and now recommended for demolition to pave way for the construction of Medical Arts Building;

**WHEREAS**, COA Circular 89-296, dated January 27, 1989, guidelines on the disposal of property and other assets of the Local Government Units, among others, provides that the Commission recognizes the destruction or condemnation of the unserviceable property only when it has no commercial value or is beyond economic repair, among other reasons stated. The head of the department and the local chief executive shall approve the disposition;

**WHEREFORE**, on motion of SP Member Dante M. Caubang, duly seconded by SP Member Charlie S. Ambasan, it was






