A RESOLUTION URGING ALL LOCAL WATER UTILITIES IN THE PROVINCE OF DAVAO ORIENTAL TO GRANT A 30-DAY EXTENSION OF BILL PAYMENTS FROM ITS DUE DATE.

WHEREAS, the President of the Republic of the Philippines, His Excellency Rodrigo Roa Duterte has declared a Nationwide State of Calamity for six (6) months to address the outbreak of the Corona Virus Disease (COVID-19) in the country;

WHEREAS, "community quarantine" should be implemented to prevent the spread of COVID-19, this measure is necessary because "there is a crisis", with no solution in sight, unless there is a vaccine in the grace of God that will be invented by scientists". The order includes a cluster of containment measures along with bans on mass gatherings and the suspension of classes;

WHEREAS, with repercussions from the outbreak including job cuts, furloughs and business closings, people are made to stay home due to the quarantine, and if income has fallen or been cut off completely and can no longer prioritize the payment of their monthly bills;

WHEREAS, we are urging all local water utilities in the Province of Davao Oriental to provide a 30-day payment extension from customers' due date without penalty;

WHEREFORE, on motion of SP Member Dennis V. Roflo, Jr., duly seconded by SP Member Rabsalon M. Lamarin, it was

RESOLVED, as it is hereby resolved, **URGING ALL LOCAL WATER UTILITIES IN THE PROVINCE OF DAVAO ORIENTAL TO GRANT A 30-DAY EXTENSION OF BILL PAYMENTS FROM ITS DUE DATE;**

RESOLVED, FINALLY, that copies of this resolution be furnished: Engr. Cesar Albarico, Manager, Mati Water District, Mr. Pacquito M. Floremonte, Manager, Matiao Water District, Manager of Balibao Water System, and other local water systems in the Province of Davao Oriental, for their information and appropriate action.




