AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2020 GENERAL FUND THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES FROM JANUARY 1 TO MARCH 31, 2020, MISCELLANEOUS PERSONNEL BENEFIT FUND, OTHER LOCALLY FUNDED PPAS, GENDER & DEVELOPMENT FUND, LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN, SENIOR CITIZEN & PERSONS WITH DISABILITIES, 5% LDRRMF-CAPITAL OUTLAY, CURRENT APPROPRIATIONS (CY 2020 20% LGDF) AND ABOLITION OF VARIOUS POSITIONS UNDER THE PROVINCIAL TREASURERS OFFICE, AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS/PROJECTS/ACTIVITIES OF THIS PROVINCE.

WHEREAS, there are programs/projects/activities of the Provincial Government aims at strengthening institutional capacity in health services delivery, implementation of activities that increase personnel performance and productivity, implementation of activities in support to the government's program against COVID-19, and other relevant projects that requires funding;

WHEREAS, the Local Finance Committee (LFC) have certified as to availability of funds needed for the implementation of the identified priority programs/projects/activities, and will be taken from the reversion of savings from salaries and other compensations of various offices, Miscellaneous Personnel Benefit Fund, Other Locally Funded Program/Projects/Activities, Gender and Development Fund, Local Council for the Protection of Children, Senior Citizen and Persons with Disabilities, 5% LDRRMF – Capital Outlay, Current Appropriation (CY 2020 20% LDGF), and funds from the abolition of various positions under the Provincial Treasurer's Office (Provincial Ordinance No. 16-19-01-2020);

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly seconded by SP Member Rabsalon M. Lamaran, it was

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. REVERSION - It is hereby approved the reversions to the CY 2020 Unappropriated balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the appropriations for the savings from salaries and other compensations of various offices, Maintenance and Other Operating Expenses (MOOE) of various offices, Miscellaneous Personnel Benefit Fund, Other Locally Funded Program/Projects/Activities, Gender and Development Fund, Local Council for the Protection of Children, Senior Citizen and Persons with Disabilities, 5% LDRRMF – Capital Outlay, Current Appropriation (CY 2020 20% LDGF), and funds from the abolition of various positions under the Provincial Treasurer's Office in the amount of P211,229,489.30, to wit:
