**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 391, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING THE CITY OF MATI YOUTH DEVELOPMENT COUNCIL, PRESCRIBING ITS DUTIES, FUNCTIONS AND RESPONSIBILITIES AND FOR OTHER PURPOSES", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.**

**WHEREAS**, SP Secretary Juvy L. Mabini of the City of Mati, submitted the City Ordinance No. 391, series of 2020, dated February 4, 2020, for review and appropriate legislative action;

**WHEREAS**, the City Government of Mati recognizes the important role of the private youth organizations composed of various sectors and shall ensure that a right-based and economic-based approach in development be integrated in the various process and regulations of the city;

**WHEREAS**, the City Government of Mati recognizes the contributing effort of the Local Youth Development Council pursuant to Chapter III, Section 23 of RA 10742, otherwise known as the "SK Reform Act of 2015", mandates the creation of a Local Youth Development Council (LYDC) in all levels;

**WHEREAS**, Section 447(a) of RA 7160, states among others that: "*the Sangguniang Panlungsod, as the legislative body of the City, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants*";

**WHEREFORE**, on motion of SP Member Ronald T. Lara, Jr., duly seconded by SP Member Nelson R. Dayanghirang, Jr., it was

**RESOLVED**, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 391, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING THE CITY OF MATI YOUTH DEVELOPMENT COUNCIL, PRESCRIBING ITS DUTIES, FUNCTIONS AND RESPONSIBILITIES AND FOR OTHER PURPOSES"**, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;


