WHEREAS, Section 447(3)(vi) of RA 7160 provides for the power of the Sangguniang Bayan "subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality";

WHEREFORE, on motion of SP Member Enrico M. Antopuesto, duly seconded by SP Member Rabsalon M. Lamarin, it was
