

A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 09, SERIES OF 2020, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING THE MUNICIPAL TRICYCLE FRANCHISE AND REGULATORY BOARD (MTFRB) OF GOVERNOR GENEROSO AND PROVIDING RULES AND REGULATIONS FOR ITS OPERATION", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, SB Secretary Val E. Amigo of the Municipality of Governor Generoso, Davao Oriental, on March 11, 2020, forwarded Municipal Ordinance No. 9, series of 2020, for review and consideration of this august body;

WHEREAS, Section 447(3)(vi) of RA 7160 provides for the power of the Sangguniang Bayan "subject to the guidelines prescribed by the Department of Transpoortation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality";

WHEREFORE, on motion of SP Member Enrico M. Antopuesto, duly seconded by SP Member Rabsalon M. Lamaran, it was
