A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 393, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ESTABLISHING A "FARMERS MARKET BAGSAKAN CENTER" IN THE CITY OF MATI, AND IMPOSING FEES AND OTHER CHARGES ON THE USE OF ITS FACILITIES", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, SP Secretary Juvy L. Mabini of the City of Mati, submitted the City Ordinance No. 393, series of 2020, for review and appropriate legislative action;

WHEREAS, City Ordinance No. 393-2020, entitled: "AN ORDINANCE ESTABLISHING A "FARMERS MARKET BAGSAKAN CENTER" IN THE CITY OF MATI, AND IMPOSING FEES AND OTHER CHARGES ON THE USE OF ITS FACILITIES", enacted by the Sangguniang Panlungsod on February 18, 2020";

WHEREAS, the established Farmers Market Bagsakan Center is located in Tagawisan, Barangay Badas, City of Mati, as a separate area from the Public Market of the City of Mati. The designated area has an open space area, which serves as an entry

point and as a service landing area for agro-fishery food products and other agricultural products/goods in bulk delivered by farmers/producers and suppliers intended for wholesale;

WHEREAS, the said City Ordinance shall cover the establishment area, administration, trading, supervision, and regulations in the operation of Farmers Market Bagsakan Center and the imposition and collection of fees and other charges as provided hereof;

WHEREAS, a public hearing was conducted on February 12, 2020 before the enactment of the said City Ordinance;

WHEREFORE, on motion of SP Member Louis N. Rabat, duly seconded by SP Member Rabsalon M. Lamaran, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 393, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ESTABLISHING A "FARMERS MARKET BAGSAKAN CENTER" IN THE CITY OF MATI, AND IMPOSING FEES AND OTHER CHARGES ON THE USE OF ITS FACILITIES"**, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;


