A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 03, SERIES OF 2020, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING ONE POSITION OF NURSE I AND TWO POSITIONS OF MIDWIFE II FOR THE MUNICIPAL HEALTH OFFICE, GOVERNOR GENEROSO, DAVAO ORIENTAL", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, SB Secretary Val E. Amigo of the Municipality of Governor Generoso, Davao Oriental, forwarded Municipal Ordinance No. 03, series of 2020, for review and consideration of this august body;

WHEREAS, Municipal Ordinance No. 03-2020, entitled: "*An ordinance creating one position of Nurse 1 and two positions of Midwife II for the Municipal Health Office, Governor Generoso, Davao Oriental*", was enacted on January 28, 2020 during its 28th Regular Session of the 17th Council of Sangguniang Bayan of Governor Generoso, Province of Davao Oriental;

WHEREAS, Article III, Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to “*review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*”;

WHEREFORE, on motion of SP Member Dennis V. Roflo, Jr., duly and jointly seconded by SP Members Rabsalon M. Lamarin, Marietta D. Palmera, and Enrico M. Antopuesto, it was


