**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 14-10-01-2020, OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING SECTIONS 1, 2, 3, AND 4, CREATING NEW SECTIONS 2-A, 2-B, 2-C, 2-D AND 2-E, ALL UNDER MUNICIPAL ORDINANCE NO. 01, SERIES OF 2009, OTHERWISE KNOWN AS "FIXING THE RATE OF MEAT, FISH AND CRUSTACEANS" PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.**

**WHEREAS**, Ms. Mary Gold B. Castres Petor, SB Secretary of the Municipality of Boston, Davao Oriental, forwarded Municipal Ordinance No. 14-10-01-2020, and the same was referred to the Committee on Trade, Industry & Investment and Economic Enterprise on April 1, 2020 Regular Session, of the 16<sup>th</sup> Sangguniang Panlalawigan of Davao Oriental, for an appropriate legislative action;

**WHEREAS**, Municipal Ordinance No. 14-10-01-2020 entitled: *AN ORDINANCE AMENDING SECTIONS 1,2,3 AND 4, CREATING NEW SECTIONS 2-A, 2-B,2-C, 2-D AND 2-E, ALL UNDER MUNICIPAL ORDINANCE NO. 01, SERIES OF 2009, OTHERWISE KNOWN AS "FIXING THE RATE OF MEAT, FISH AND CRUSTACEANS", PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES*", was enacted by the 14<sup>th</sup> Sangguniang Bayan of Municipality of Boston, Davao Oriental, on its 24<sup>th</sup> Regular Session, held last January 20,2020, and was approved by Honorable Mayor Rowell F. Rosit, on January 27, 2020;

**WHEREAS**, the subject Municipal Ordinance No. 14-10-01-2020 was enacted purposely to amend Sections 1,2,3, and 4 under Municipal Ordinance No. 01, series of 2009, and added new sections 2-A, 2-B, 2-C, 2-D, 2-E to fix the price and re-classification of meat, fish, and crustaceans in the said municipality;

**WHEREAS**, it is strictly prohibited for any person or group of persons to sell fish and meat in their private market or in their houses aside from the Public Market with the price and re-classification of meat, fish and crustaceans provided under sections 2-A, 2-B, 2-C, 2-D, 2-E of this ordinance;

**WHEREAS**, a Public Hearing was conducted on December 6, 2019 at San Nicolas de Tolentino Parish Hall, Municipality of Boston, Davao Oriental;

**WHEREAS**, Article III, Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to "*review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*";

**WHEREFORE**, on motion of SP Member Louis N. Rabat, duly and jointly seconded by SP Members Ronald T. Lara, Jr., Marietta D. Palmera, and Dennis V. Roflo, Jr., it was

**RESOLVED**, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 14-10-01-2020, OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING SECTIONS 1, 2, 3, AND 4, CREATING NEW SECTIONS 2-A, 2-B, 2-C, 2-D AND 2-E, ALL UNDER MUNICIPAL ORDINANCE NO. 01, SERIES OF 2009, OTHERWISE KNOWN AS "FIXING THE RATE OF MEAT, FISH AND CRUSTACEANS" PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES"**, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;


