A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 05-2019 OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ENACTING THE CHILDREN'S WELFARE CODE OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL PROVIDING FOR A COMPREHENSIVE CHILDREN AND FAMILY SUPPORT SYSTEM FOCUSING IN THE MILLENNIUM DEVELOPMENT GOALS (MDGs) AND FOR OTHER PURPOSES", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIAN.

WHEREAS, Mr. Val E. Amigo, SB Secretary of Governor Generoso, Davao Oriental, submitted a letter, dated February 11, 2020, submitting Municipal Ordinance No. 5-2019, for review and consideration of the Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 5-2019, entitled: "AN ORDINANCE ENACTING THE CHILDREN'S WELFARE CODE OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL PROVIDING FOR A COMPREHENSIVE CHILDREN AND FAMILY SUPPORT SYSTEM FOCUSING IN

THE MILLENIUM DEVELOPMENT GOALS (MDGs) AND FOR OTHER PURPOSES", was enacted by the Sangguniang Bayan on November 19, 2019;

WHEREAS, the vision for the Filipino Children is laid down in the Philippine National Strategic Framework for Plan Development for Children. Thus, provides the road map towards the progressive realization of children's right based approach to planning and programming woven across the child, stages of development;

WHEREAS, the children everywhere have the right to survival, to develop to the fullest, the protection from harmful influences, abuse and exploitation, and to participate fully in family, cultural and social life;

WHEREAS, Section 468(a)(1)(i) of RA 7160, states that: "*the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*";

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly seconded by SP Member Ronald T. Lara, Jr., it was
