A RESOLUTION GRANTING AUTHORITY THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT AND/OR UNDERSTANDING WITH AGENCIES, INSTITUTIONS, ORGANIZATIONS AND OTHER PERTINENT ENTITIES FOR THE IMPLEMENTATION OF THE *NAGKAKAISANG LINGKOD-BAYAN NG DAVAO ORIENTAL-FOREST LANDSCAPE RESTORATION FOR SUSTAINABLE DEVELOPMENT (NLD-FLRSD)* PROGRAM IN THE PROVINCE.

WHEREAS, for general welfare purposes embodied in RA 7160, the Provincial Executive Order No. 10, series of 2018, instituted *Nagkakaisang Lingkod-bayan ng Davao Oriental-Forest Landscape Restoration for Sustainable Development (NLD-FLRSD)* Program as the local approach to ensure inclusive and sustainable development of the province's landscape as well as forest resources and for local communities in harmony with the National Greening Program (NGP) and with the United Nations (UN) Strategic Plans for Forests 2030, with AmBisyon Natin 2040, Philippine Development Plan-Davao Region Development Plan-Provincial Development and Physical Framework Plan (PDP-DRDP-PDPFP) 2017-2022, which are all anchored on the UN Sustainable Development Goals, and also in alignment with the Ancestral

Domain Sustainable Development and Protection Plans (ADSDPP) of the Indigenous Peoples of the Province;

WHEREAS, NLD-FLRSD components include: a) *Forestry-based Livelihood Promotion in forest and non-forest lands to include ancestral lands and A&D areas*, b) *Trees-for-Peace in conflict areas*, c) *Assisted Natural Regeneration and Agro-Forestry*, d) *Collaborative Studies and Promotion and Production of ecologically and economically important local tree species*, e) *Wildlife Habitat Conservation and Protection*, and f) *Non-timer based Livelihood Promotion*, which are all necessary for an effective, efficient, and sustainable management and development of forests and general landscape with the communities that are dependent on it;

WHEREAS, being a comprehensive, collaborative, inclusive and participatory program, it is but prudent that NLD-FLRSD implementation shall be in partnership with pertinent agencies, institutions, and organizations;

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly seconded by SP Member Ronald T. Lara, Jr., it was

RESOLVED, as it is hereby resolved, **AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT AND/OR UNDERSTANDING WITH THE DIFFERENT AGENCIES THROUGH ITS REPERESNTATIVES FOR THE IMPLEMENTATION OF THE NAGKAKAISANG LINGKOD-BAYAN NG DAVAO ORIENTAL-FOREST LANDSCAPE RESTORATION FOR SUSTAINABLE DEVELOPMENT (NLD-FLRSD) PROGRAM IN THE PROVINCE;**


