A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 14-05-01-2020 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE PROHIBITING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS IN CERTAIN PLACES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Ms. Mary Gold B. Castres-Petor, SB Secretary of the Sangguniang Bayan of Boston, Davao Oriental, forwarded a letter, dated January 29, 2020, submitting Municipal Ordinance No. 14-05-01-2020, for review and consideration of the Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 14-05-01-2020, entitled: "AN ORDINANCE PROHIBITING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS IN CERTAIN PLACES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES", was enacted by the Sangguniang Bayan on January 13, 2020;

WHEREAS, the enactment of the Municipal Ordinance No. 14-05-01-2020 is within the legal powers of the Sanggunian Bayan;

WHEREAS, Section 468(a)(1)(i) of RA 7160, states that: "*the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*";

WHEREFORE, on motion of SP Member Joselito B. Villademoso, duly and jointly seconded by SP Members Charlie S. Ambasan, and Enrico M. Antopuesto, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 14-05-01-2020 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE PROHIBITING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS IN CERTAIN PLACES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES"**, **CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;**
