EXECUTIVE ORDER NO. <u>13</u> Series of 2020

AN ORDER AMENDING EXECUTIVE ORDER NO. 12 DECLARING THE PROVINCE OF DAVAO ORIENTAL UNDER ENHANCED COMMUNITY QUARANTINE STARTING 12:01 AM APRIL 7, 2020 UNTIL 11:59 PM APRIL 19, 2020 AND ADOPTING THE GUIDELINES FOR THE EFFECTIVE IMPLEMENTATION OF AN ENHANCED COMMUNITY QUARANTINE OVER DAVAO REGION.

WHEREAS, President Rodrigo Roa Duterte issued Presidential Proclamation No. 922 declaring a state of Public Health Emergency throughout the Philippines;

WHEREAS, on April 2, 2020, the Davao Region COVID 19 Task Force issued Order No. 2020-008, prescribing the guidelines for the effective implementation of an enhanced community quarantine over Davao Region to suppress the spread of COVID 19 infection;

WHEREAS, Executive Order No. 12 placed the province under enhanced community quarantine and the quidelines relative thereto;

WHEREAS, there is a need for unhampered mobility of residents, goods, and products within the province to facilitate efficient delivery of services;

NOW, THEREFORE, I, NELSON L. DAYANGHIRANG, Governor of the Province of Davao Oriental, by virtue of the powers vested in me by laws, do hereby order the following:

Section 1. Adoption. All sections from Executive Order No. 12 are hereto adopted except Section 3.1 on transportation which reads: "All private vehicles and any mode of mass public transportation, except ambulances and/or COVID 19 related vehicles shall be prohibited from crossing inter-LGU borders."

Section 2. Provision of Additional Guideline in Inter-municipal travels.

- Inter-municipal travels shall not be impeded. Mayors of City and Municipal LGUs
 are directed to not close their municipal borders for inter-municipality travels in
 order to ensure the efficient and fast delivery of goods and services and the safe
 passage of people especially health care workers and frontliners in the COVID
 response team;
- 2. However, travelers shall only be allowed to travel and cross inter-municipal/city borders if:
 - a. they have in their possession proper identification and/or, as the case maybe, Home Quarantine Pass;
 - b. they are wearing face masks;

and shall be subjected to pertinent screening protocols at their respective borders such as but not limited to temperature screening, inspection, travel history.

SECTION 3. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect on starting April 07, 2020, at 12:01 AM and shall remain in full force until April 19, 2020, or otherwise, amended, superseded or recalled.
