# PROVINCIAL ORDINANCE NO. 16-27-04-2020

AN ORDINANCE REQUIRING GOVERNMENT INSTITUTIONS IN DAVAO ORIENTAL TO PATRONIZE LOCALLY PRODUCED AND PROCESSED PRODUCTS/FOOD AND DELICACIES IN ALL ITS OFFICIAL TRANSACTIONS.

WHEREAS, pursuant to the provisions of Section 16 of the Local Government Code which states that: "every LGU shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare";

**WHEREAS**, it is of the best interest of the government to require the provision of local products whenever catering services are served;

WHEREAS, the full implementation of this ordinance shall accrue to the growth and development of the countryside and shall directly benefit the farming sector in terms of more production and marketing enterprise activities;

WHEREAS, the economic gains such as but not limited to the generation of higher income for farmers and various social benefits derived from its implementation and generate more revenues to the government;

WHEREAS, the Department of Trade and Industry and Department of Agriculture advocate the concept of so called priority local product utilization as a motivation to producers especially the farming sector and food establishments;

WHEREAS, relative to the observance of balance diet, local products can best provide nutritious food value to the body;

WHEREAS, financial-wise it is affordable and less expensive on the part of the government;

WHEREFORE, on motion of SP Member Nelson R. Dayanghirang, Jr., duly seconded by SP Member Dennis V. Roflo, Jr., it was

Be it ordained by the 16<sup>th</sup> Sangguniang Panlalawigan of Davao Oriental in session duly assembled that:

**SECTION 1 – TITLE.** This Provincial Ordinance shall be known as "An Ordinance requiring government institutions in Davao Oriental to patronize locally produced and processed products/food and delicacies in all its official transactions

SECTION 2 – STATEMENT OF POLICY. It shall be the policy of the Provincial Government of Davao Oriental to:

- a. Tap the services of food establishments to provide local products whenever trainings and seminars are conducted in the Province;
- Enter into contract with local food establishments to provide local products without prejudice to other business providers;
- c. Enjoin all food establishments, whenever necessary, to extend to the government locally produced and processed products/food and delicacies in order to promote their sources of livelihood.

**SECTION 3 – DEFINITION OF TERMS.** For purposes of this ordinance, the following terms are defined accordingly:

- a. Agencies units attached to the departments which operate and function in accordance with their respective characters, law or orders creating them except as provided in the administrative code.
- b. Establishment a place of business or production area.
- c. Local foods and delicacies those which are produced locally and processed for purposes of consumption within the province of Davao Oriental.
- d. Cater to provide food provision.
- e. Services employment in any duties or work for another or others and the like.

SECTION 4 - PENALTY. Government entity to be found violating the provision of this ordinance shall be made to explain in writing citing the reason for non compliance.

SECTION 5 - APPROPRIATION. The Provincial Government shall set aside reasonable of initial funding to ensure the implementation of the above-cited ordinance.

SECTION 6 - EFFECTIVITY. This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of local and general circulation posted in at least two (2) conspicuous places in the Province of Davao Oriental.

ENACTED: APRIL 22, 2020.
