A RESOLUTION RECOMMENDING TO THE BARANGAY COUNCIL OF BACULIN, MUNICIPALITY OF BAGANGA, TO FILE A VERIFIED PETITION BEFORE THE REGIONAL TRIAL COURT (RTC), TO DECLARE MUNICIPAL ORDINANCE 37, SERIES OF 2019, OF THE SANGGUNIANG BAYAN OF BAGANGA, NULL AND VOID, AND TO PROHIBIT THE LGU AND OTHER SUBORDINATES IN CARRYING MUNICIPAL ORDINANCE NO. 37, SERIES OF 2019, INTO EFFECT.

WHEREAS, Republic Act 7160 mandated the local sanggunian as an APPROVING AUTHORITY to name and to change the name of the public school amending Republic Act 6655 whereby the Secretary of the Department of Education is mandated as the approving authority;

WHEREAS, the Sangguniang Bayan of Baganga approved Municipal Ordinance No. 37, series of 2019, to rename "Baculin National High School" to "OUR LADY OF GUADALUPE NATIONAL HIGH SCHOOL" upon receipt of the Local School Board Resolution No. 1, series of 2018;

WHEREAS, the Sangguniang Bayan of Baganga, failed to conduct committee meeting to validate, confirm, and verify the compliance and basis of the Local School Board Resolution No. 1, series of 2018, for the renaming of the said school;

WHEREAS, the sentiment of the general assembly of Barangay Baculin expressed in a legally held Barangay general assembly in compliance to Republic Act 7160, was not considered in the approval of the Municipal Ordinance No. 37, series of 2019;

WHEREAS, the utmost consideration of the people in "BACULIN" to continuously enjoy, honoured, and feel proud of their birthplace that became the important part of their existence and forever treasures the memories of all inhabitants was not considered, deliberated and contemplated in the approval of the Municipal Ordinance No. 37, series of 2019;

WHEREAS, asserting the approval of the Municipal Ordinance No. 37, series of 2019, was done in haste with exercise of grave of abuse of AUTHORITY and discretion by the Sanguniang Bayan of Baganga, by deliberately, cunningly and maliciously, ignored the sentiments, opinions, and recommendations of the majority of the inhabitants therein;

WHEREAS, interestingly, the court of law shall now serve as the rightful venue for an intelligent discussion with all concerned parties grounded on rational, sensible and well established facts, reasons, evidences and history as basis for peaceful resolution of the case;

WHEREFORE, on motion of SP Member Laureano B. Taya, duly and jointly seconded by SP Members Ronald T. Lara, Jr., and Anacleto P. Macatabog, it was

RESOLVED, as it is hereby resolved, RECOMMENDING TO THE BARANGAY COUNCIL OF BACULIN, MUNICIPALITY OF BAGANGA, TO FILE A VERIFIED PETITION BEFORE THE REGIONAL TRIAL COURT (RTC), TO DECLARE MUNICIPAL ORDINANCE 37, SERIES OF 2019, OF THE SANGGUNIANG BAYAN OF BAGANGA, NULL AND VOID, AND TO PROHIBIT THE LGU AND OTHER SUBORDINATES IN CARRYING MUNICIPAL ORDINANCE NO. 37, SERIES OF 2019, INTO EFFECT;
