A RESOLUTION CONFIRMING THE APPROVAL ON THE VALIDITY OF MUNICIPAL ORDINANCE NO. 02-2020 OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRE CRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CATEEL, PROVINCE OF DAVAO ORIENTAL", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Ms. Romilda A. Marquez, SB Secretary of Cateel, submitted the Municipal Ordinance No. 02-2020 of the said municipality, for review and confirmation of this Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 02-2020, entitled: "AN ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRE CRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CATEEL, PROVINCE OF DAVAO ORIENTAL", was enacted on January 7, 2020;

WHEREAS, the Municipal Ordinance No. 02-2020 was enacted purposely to regulate the sale, distribution, possession and use of firecrackers or pyrotechnic devices and such other similar devices, and the exploding of firecrackers and other explosion within the territorial jurisdiction of the Municipality of Cateel in furtherance of public safety, peace, order and security;

WHEREAS, Section 468(a)(1)(i) of RA 7160, states that: "*the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*";

WHEREFORE, on motion of SP Member Nelson R. Dayanghirang, Jr., duly seconded by SP Member Dennis V. Roflo, Jr., it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE VALIDITY OF MUNICIPAL ORDINANCE NO. 02-2020 OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRE CRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CATEEL, PROVINCE OF DAVAO ORIENTAL"**, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;
