A RESOLUTION CONFIRMING THE APPROVAL ON THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2020-01 OF THE MUNICIPALITY OF LUPON, PROVINCE OF DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE PRESCRIBING SAFETY MEASURES AND OTHER RELATED REGULATIONS IN ALL GASOLINE STATIONS WITHIN THE TERRITORIAL LIMIT OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL". CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH THE LAW.

WHEREAS, Ms. Sharon G. Balingit, SB Secretary of Lupon, submitted the Municipal Ordinance No. 2020-01 of the said municipality, for legislative review and appropriate action of this Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 2020-01, entitled: "AN ORDINANCE PRESCRIBING SAFETY MEASURES AND OTHER RELATED REGULATIONS IN ALL GASOLINE STATIONS WITHIN THE TERRITORIAL LIMIT OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL.", was enacted by the Sangguniang Bayan on February 24, 2020;

WHEREAS, Municipal Ordinance No. 2020-01 is in accordance with DILG Memorandum Circular No. 2006-66, dated June 20, 2006, prescribing safety measures in all gasoline stations in cities and municipalities;

WHEREAS, Section 468(a)(1)(i) of RA 7160, states that: "*the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor*";

WHEREFORE, on motion of SP Member Nelson R. Dayanghirang, Jr., duly seconded by SP Member Dennis V. Roflo, Jr., it was
