**A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO APPLY, NEGOTIATE AND CONTRACT A LOAN, WITH THE LANDBANK OF THE PHILIPPINES (LBP) TO FUND VARIOUS PROJECTS, PROGRAMS AND ACTIVITIES (PPAs) IN SUPPORT TO THE DEVELOPMENT AGENDA OF THE PROVINCE OF DAVAO ORIENTAL.**

**WHEREAS**, the Honorable Governor submitted a request to the Sangguniang Panlalawigan for a passage of a resolution authorizing him to apply, negotiate and contract a loan for and in behalf of the Province of Davao Oriental, with the Landbank of the Philippines (LBP);

**WHEREAS**, the proceeds of the loan are intended to fund projects in support to the following provincial development agenda: *defeat poverty, safeguard the environment, expand access to infrastructure, utilities and social services, sustain public order and safety and strengthen effective governance*, all of which covers the top priority sectors on *agriculture, tourism, health, environment, infrastructure and governance*;

**WHEREAS**, the specific programs, projects and activities shall be finalized only after having met the administered criteria of prioritization to determine the viability of each of the proposed project, and the PPAs shall be identified during the request for the ratification of the loan agreement;

**WHEREAS**, Section 465(b)(vi) of RA 7160 states that the Provincial Governor shall "represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";


**WHEREFORE**, on motion of SP Member Laureano B. Taya, duly and jointly seconded by SP Members Enrico M. Antopuesto, Dennis V. Roflo, Jr. and Charlie S. Ambasan, it was

**RESOLVED**, as it is hereby resolved, **GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. 


