A RESOLUTION CONFIRMING THE APPROVAL ON VALIDITY OF CITY ORDINANCE NO. 420, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT FOR CITIES AND MUNICIPALITIES PURSUANT TO 2ND PARAGRAPH OF 3.7 OF THE LOCAL BUDGET CIRCULAR NO. 125, DATED APRIL 7, 2020", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, SP Secretary Juvy L. Mabini of the City of Mati, Davao Oriental submitted City Ordinance No. 420, series of 2020, for review of this august body;

WHEREAS, City Ordinance No. 420, series of 2020, entitled: "AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT FOR CITIES AND MUNICIPALITIES PURSUANT TO 2ND PARAGRAPH OF 3.7 OF THE LOCAL BUDGET CIRCULAR NO. 125, DATED APRIL 7, 2020", was enacted by the Sangguniang Panlungsod, on April 14, 2020;

WHEREAS, Republic Act No. 11469, otherwise known as the Bayanihan to Heal as One Act grants the President Rodrigo Duterte, the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, Local Budget Circular (LBC) No. 125, dated April 7, 2020 provides the guidelines on the release and utilization of the Bayanihan Grant to Cities and Municipalities;

WHEREAS, 2nd paragraph of 3.7 of the LBC No. 125, states that: "*For easy monitoring/tracking of the utilization of the allocation of each city and municipality, a special account in the general fund (SAGF) for the BGCM shall be created through an ordinance by the local sanggunian pursuant to Section 313 of PA No. 7160. The creation of an SAGF for the BGCM may also be done by the local sanggunian through inclusion in the pertinent appropriation ordinance authorizing a supplemental budget covering the BGCM*";

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly and jointly seconded by SP Members Dennis V. Roflo, Jr., and Ronald T. Lara, Jr., it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE VALIDITY OF CITY ORDINANCE NO. 420, SERIES OF 2020, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT FOR CITIES AND MUNICIPALITIES PURSUANT TO 2ND PARAGRAPH OF 3.7 OF THE LOCAL BUDGET CIRCULAR NO. 125, DATED APRIL 7, 2020"**, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW;
