WHEREAS, SP Secretary Juvy L. Mabini of the City of Mati, Davao Oriental submitted City Ordinance No. 414, series of 2020, for review of this august body;

WHEREAS, City Ordinance No. 414, series of 2020, entitled: "An Ordinance Adopting Task Force Order No. 2020-007 of the Davao Region COVID-19 Task Force (RTF 11-COVID-19), "PRESCRIBING ADDITIONAL GUIDELINES FOR THE EFFECTIVE IMPLEMENTATION OF THE GENERAL COMMUNITY QUARANTINE IN

DAVAO REGION (FROM MARCH 26, 2020, 5: A.M UNTIL APRIL 19, 2020, 11:59 P.M.)”, was enacted by the Sangguniang Panlungsod, on March 31, 2020;

WHEREAS, Article III, Section 468(a)(1)(i) of RA 7160, provides for the legal basis of the Sangguniang Panlalawigan to “review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunians and of the mayor”;

WHEREFORE, on motion of SP Member Joselito B. Villademosa, duly and jointly seconded by SP Members Enrico M. Antopuesto, Lemuel Ian M. Larcia, and Dennis V. Roflo, Jr., it was


