Executive Order No. 24 Series of 2020

CREATING AN ADHOC COMMITTEE TO STUDY AND EVALUATE THE NICKEL ORE DONATION PROPOSED BY THE TQGT MINERAL DEVELOPMENT CORPORATION

WHEREAS, The TQGT Mineral Development Corporation (MDC) applied for and was issued Explanation Permit No. EP 00001-2019-XI by the Mineral and Geosciences Bureau (MGB) on August 28, 2019;

WHEREAS, by virtue of the said EP, TQGT MDC conducted mineral activities at the Municipality of Governor Generoso, Davao Oriental, wherein nickel ore materials were extracted as samples;

WHEREAS, TQGT MDC proposes that the sample nickel ore materials they have extracted be donated to the Provincial Government of Davao Oriental.

NOW, THEREFORE, I, NELSON L. DAYANGHIRANG, Governor of the Province of Davao Oriental, by virtue of the power vested in me by the Constitution and exciting laws, do hereby order the following:

Section 1. CREATION - There is hereby created an AD HOC Committee with the assigned functions to study and evaluate the nickel ore donation proposed by TQDT Mineral Development Corporation and upon completion of said study/evaluation, to render a report and recommendation to the Governor.

Section 2. COMPOSITION- The ADHOC Committee shall have following composition:
