## EXECUTIVE ORDER NO. 32 Series of 2020

REITERATING THE HEALTH AND SAFETY GUIDELINES GOVERNING THE OPERATIONS OF TOURISM AND ACCOMMODATION ESTABLISHMENTS, FASTFOOD AND RESTAURANTS AND OTHER PUBLIC ESTABLISHMENTS UNDER THE MODIFIED GENERAL COMMUNITY QUARANTINE AND PROVIDING THE GUIDELINES FOR THE NEW NORMAL SET-UP

**WHEREAS**, President Rodrigo Roa Duterte issued Executive Order No. 112 imposing an enhanced community quarantine in high-risk areas and a general community quarantine in other parts of the country and adopting the *Omnibus Guidelines* in the implementation thereof;

WHEREAS, the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases classified the province of Davao Oriental under Modified General Community Quarantine that allowed for the opening of its provincial borders and shifted its screening, active case finding and monitoring at the community or barangay level;

WHEREAS, the Department of Tourism has issued administrative order no. 2020-002 prescribing the guidelines on the operation of hotels and other accommodation establishments under the new normal, Memorandum Circular No 2020-003 Prescribing The Health And Safety Guidelines Governing The Operations Of Tourist Land Transport Services Under The New Normal, Memorandum Circular No 2020-004 Prescribing The Guidelines Governing The Operations Of Dot-Accredited Restaurants Under The New Normal, Memorandum Circular No. 2020-005 prescribing the interim guidelines for applications for accreditation, and Memorandum Circular No. 01,s. 2020 or the rules and regulations to govern the accreditation of surfing camps and Filipino surfing instructors;

**WHEREAS**, the Department of Trade and Industry has issued guidelines on the minimum health protocol for dine-in restaurants and fast-food establishments under the new normal;

**WHEREAS**, despite the need to keep its tourism industry thriving, the provincial government is still expected to act as stewards of the general health and welfare of its people and tourists alike;

**NOW, THEREFORE**, by the authority vested in me as Provincial Governor by the Constitution and the laws of the Republic of the Philippines, **I, NELSON L. DAYANGHIRANG**, do hereby order:

**SECTION 1. ADOPTION.** The following issuances are hereby adopted:

## SECTION 2. CREATION AND COMPOSITION OF THE JOINT INSPECTION TEAM

- 2.1 To effectively monitor the implementation of these minimum health and safety guidelines and to ensure that establishments are adhering to these set protocols, each city/municipal LGU shall create a city/municipal joint inspection team.
- 2.2 The Joint Inspection Team shall be composed of the following members:
  - a) City/Municipal Tourism Officer or his/her representative;
  - b) City/Municipal Health Officer or his/her representative;
  - c) City/Municipal Business Permit and Licensing Office representative;
  - d) City/Municipal Sanitary Officer;
  - e) City/Tourism Council representative; and
  - f) Department of Trade and Industry representative.

**SECTION 3. SEPARABILITY CLAUSE.** If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

**Section 4. REPEALING CLAUSE.** Previous issuances or parts thereof in conflict with or inconsistent to the provisions of this Executive Order are hereby repealed or modified accordingly.

**Section 5. EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately.
