AN ORDINANCE CREATING THE POSITION OF ONE (1) SUPERVISING ADMINISTRATIVE OFFICER, WITH SALARY GRADE 22 UNDER THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration is a letter from the Honorable Governor Nelson L. Dayanghirang requesting for the creation of one (1) Supervising Administrative Officer with Salary Grade 22 under the Office of the Davao Oriental Provincial Medical Center;

WHEREAS, the said position shall spearhead the Internal Administrative Support Sections as well as the Arcillary Sections of the Davao Oriental Provincial Medical Center;

WHEREAS, Section 468 (a) (1) (viii), RA 7160 provides that the Sangguniang Panlalawigan shall: "Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from

provincial funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the Provincial Government”;

WHEREFORE, on motion of SP Member Hon. Dennis V. Roflo, Jr., duly and jointly seconded by SP Members Anacleto P. Macatabog, and Enrico M. Antopuesto, it was

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental in session duly assembled that:

SECTION 1. There is hereby created under the Davao Oriental Provincial Medical Center a position of One (1) Supervising Administrative Officer with Salary Grade 22.

SECTION 2. The Provincial Human Resource Management Development Office (PHRMDO) shall define its duties and responsibilities in accordance with the existing Civil Service Rules and Regulations.

SECTION 3. The necessary funding requirements for the herein position shall be included in the CY 2021 General Fund Annual Budget of the Provincial Government.

SECTION 4. This Ordinance shall take effect immediately upon approval hereof.


