AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2020 GENERAL FUND THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES, SAVINGS FROM MISCELLANEOUS PERSONNEL BENEFITS FUND (MPBF), SAVINGS FROM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) AND CAPITAL OUTLAY OF DIFFERENT OFFICES, AND APPROPRIATIONS FROM 20% LOCAL GOVERNMENT DEVELOPMENT FUND (LGDF), IN THE TOTAL AMOUNT OF P69,801,988.00, AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS/PROJECTS/ACTIVITIES OF THIS PROVINCE.

WHEREAS, there are programs/projects/activities of the Provincial Government which aim for strengthening the institutional capacity in the delivery of health and social services, the implementation of activities that increase personnel performance and productivity, and other infrastructure projects that requires funding;

WHEREAS, the Local Finance Committee (LFC) has certified as to the availability of funds needed for the implementation of the identified priority programs/projects/activities, and will be taken from the reversion of savings from salaries and other compensations of various offices, savings from MPBF, savings from MOOE and Capital Outlay of different offices, and appropriations from 20% Local Government Development Fund (LGDF);

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly and jointly seconded by SP Members Marietta D. Palmera, and Rabsalon M. Lamarin, it was

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental in session duly assembled that:

SECTION 1. REVERSION - It is hereby approved the reversions to the CY 2020 Unappropriated Balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the appropriations for the savings from salaries and other compensations of various offices; savings from MPBF; savings from MOOE and Capital Outlay of different offices, and appropriations from 20% Local Government Development Fund (LGDF) in the amount of **P69,801,988.00**, to wit:

a. Salary savings of various offices/departments . . .	<u>P14,393,275.96</u>
b. Savings from Miscellaneous Personnel Benefit Fund (MPBF)	<u>P30,770,975.00</u>
c. Savings from Maintenance & Other Operating Expenses (MOOE).	<u>P16,146,927.04</u>
d. Savings from Capital Outlay.	<u>P 1,600,000.00</u>
e. CY 2020 Current Appropriations (20% LGDF -PPAs).	<u>P 4,551,250.00</u>
f. CY 2019 Continuing Appropriations (20% LGDF -PPAs).	<u>P 2,219,560.00</u>
g. Transportation Allowance of Vice Governor's Office (SP Resolution No. 16-682-10-2020).	<u>P 120,000.00</u>
TOTAL	<u>P69,801,988.00</u>

SECTION 2. EFFECTIVITY- This Ordinance shall take effect immediately upon approval.
