RESOLVED, to declare Appropriation Ordinance No. 04, series of 2020, of the Municipality of Tarragona, Davao Oriental **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and reiterating previous recommendation that the LGU will adapt measure by way of partially implementing salary increases, or prioritize implementation of other compensation, or the no filling-up/abolishing some of the vacant funded positions except for the mandatory one, in order to reduce the aforesaid excess in the amount equivalent to that which is within the exact 45% Personal Services Limitation;

RESOLVED FURTHER, to inform the Municipality of Tarragona, Davao Oriental that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Tarragona, Davao Oriental through the Municipal Mayor.


