RESOLVED FURTHER, to inform the Municipality of Governor Generoso, Davao Oriental that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental through the Municipal Mayor.


